SAN JUAN COUNTY COUNTY ZONE PAY: Add'l \$3.75 per hour paid by contractor.

HAZARDOUS EMPLOYMENT: 50 feet to 80 feet - 1.5 straight time rate of pay.

FOREMAN REQUIREMENT: Required on any job with three (3) or more Journeyman Wireman. Can supervise up to ten (10) Journeymen. GENERAL FOREMAN required after 3rd crew.

WORK DAY: Eight hours between 8:00 am and 4:30 pm shall be the normal work day.

PAYDAY: 5 day holdback.

WORK WEEK: 40 hours, Monday thru Friday, shall constitute a work week.

HOLIDAYS: New Year's Day, Martin Luther King Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Day after Thanksgiving, Christmas Eve and Christmas Day.
